

**ZONEPERFECT MACROS BAR SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

The ZonePerfect Macros Bar Sweepstakes ("Sweepstakes") is sponsored by Abbott Laboratories Inc. ("Sponsor"), 100 Abbott Park Road, Abbott Park, IL 60064, and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on April 6, 2021 at 12:00 PM Eastern Time ("ET") and ends on May 31, 2021 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of one of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. Boxes will be allowed), city, state, and zip code. Upon the successful submission of the registration information, an entrant will receive one (1) entry into the Sweepstakes.

**Entry Limit:** There is a limit of one (1) email entry per person per day. If more than one (1) entry per day is received from the same person, telephone number and/or e-mail address the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor's sole discretion, may not be eligible to win a prize. 4. **RANDOM DRAWING:** On or around June 1, 2021, the Administrator will randomly select one (1) potential winner grand prize winner, three (3) potential first place prize winners, and ten (10) potential second place prize winners, from all eligible entries received. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.
5. **PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:**
  - A. **Grand Prize (1):** The grand prize is a Peloton Bike+ and \$405 (awarded via Chase Quick Pay) that winner has the option to use towards a Peloton membership and gear. ("Grand Prize"). There will be one (1) Grand Prize. The ARV of the Grand Prize is \$3,100.
  - B. **First Place Prizes (3):** Each first place prize is \$600 via Chase Quick Pay that may be used towards a meal plan delivery service at winner's discretion ("First Place Prize"). There will be three (3) First Place Prizes. The ARV of each First Place Prize is \$600.
  - C. **Second Place Prizes (10):** Each second place prize is Zone Perfect swag ("Second Place Prize"). Specific items will be determined by Sponsor in its sole discretion. There will be ten (10) Second Place Prizes. The ARV of each Second Place Prize is \$100.
  - D. **Total ARV:** The total ARV of the prizes is \$5,900.
  - E. **Odds of Winning:** The odds of winning a prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period.
  - F. **General Conditions:** All costs and expenses not specifically included herein are solely the winner's responsibility. There is a limit of one (1) prize per person/household. In no event will more than the stated number of prizes, be awarded. THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY**
